Segment 1 Course Provisions:

Safe Start Driving Academy will provide a minimum of 24 hours of classroom instruction, 6 hours of behind-the wheel (BTW) instruction and 4 hours of observation time in a dual controlled automobile which is fully insured, covering each student enrolled in the program. Classroom instruction and BTW instruction will be out of the office listed above. Students must satisfactorily complete all the BTW instruction and must pass quizzes and the 80 question State Test with a score of 70% or greater in order to be issued a Segment 1 Certificate.

Students who miss classroom instruction will be assigned a makeup date by the instructor. If a date is not satisfactory or a mutual date cannot be reached then the student will be required to make up the date for the same class missed during the next class session. All missed BTW instruction will be rescheduled between the student and the instructor. If a class or BTW is cancelled due to weather then all schedules are pushed back (number of days dependent on days missed). The classroom instruction must be over a minimum of a 3 week period and all BTW instruction must be completed no later than 3 weeks after the classroom instruction has been completed. Any missed drives without a 24-hour notification will be subject to a \$20 charge. No certificate will be issued until all charges are paid in full. Also please note that any tuition not paid by Monday of the 2nd week, drive times may not be scheduled.

Method of Payment:

The total cost of SEGMENT 1 ONLY is \$289.00. There is a \$89.00 registration deposit that is required and will be applied to the total tuition. Payments may be made by cash, money order, check or credit card (Visa or Mastercard). Tuition must be paid in full on or before the 2nd week of class begins. There will be a \$30 charge for returned checks. Safe Start Driving Academy will provide the textbooks for the duration of the course as needed. For lost or defaced/damaged books there will be a \$40 charge. There are two ways to register. Complete this contract and mail or walk in to the address at the top of this page.

Refund Policy:

If a student cancels by the first day of class, 100% of the tuition costs paid will be refunded. After the 1st or 2nd day of class, 75% of the tuition cost paid will be refunded. After the 3rd class day, no refund will be honored. In case of misconduct by students or parents, no refund will be given and student may be expelled. If student does not successfully complete classroom and/or driving instruction, no refund will be given.
